The following are the agreement terms for vendor space. As a Vendor, your acceptance of these terms shall constitute a binding agreement. It is agreed that each Vendor will abide by all terms listed in this agreement.

1. **LSGF.** The word "LSGF" as used herein shall mean LIADO'S San Gennaro Festa, their officers, agents and any employees acting for it, in the management of this event.
2. **ELIGIBLE VENDORS.** LSGF reserves the right to determine whether any company or product is eligible under the standards for inclusion in the festa.
3. **ELIGIBLE PRODUCTS.** All products and services to be sold during the LSGF must be included on the Application. LSGF reserves the right to exclude the sale of any product based on overall show presentation, or that are in conflict with exclusive contracts held by LSGF with other Vendors. Vendor will be notified in advance of any such exclusion and have the right at the time of the application to determine if they still want to participate.
4. **ADMISSION.** Gated event. Daily admission cost \$5.00. Children under 12 are free.
5. **LIMITATION OF LIABILITY.** The Vendor agrees to make no claim for any reason whatsoever, including negligence, against LSGF, its members, agents,

employees or the owners of the Festa premises for loss, theft, damage or destruction of property or for any injury to Vendor or its employees while in the Festa quarters.

6. **BOOTH INFORMATION.** The cost of renting a space with lights and electricity:

\$400.00	10 x 10
\$600.00	10 x 20
\$200.00	10 x 10 space for beverage or snacks

Vendor must provide his own tent, tables, commercial electric cords etc. Booth space will be assigned by LSGF.

7. **INSURANCE.** Insurance is the responsibility of the Vendor and is recommended. LSGF is not responsible for replacement of lost or stolen goods. Vendors are responsible for obtaining their own general liability insurance for the show dates, including set-up and take-down. Vendors will indemnify LSGF for claims/suits arising between Vendors and attendees regarding exhibit rental.

8. **SUBLEASING.** Vendors may not sublet their spaces, or any part thereof.

9. **FIRE AND SAFETY LAWS.** All federal, state and city regulations pertaining to fire and safety must be adhered to. No open flames, lit candles or burning of incense will be allowed. All commercial electrical cords must be grounded and be UL approved.

10. **COMPLIANCE WITH LAWS/STANDARDS.** Vendors are responsible for meeting all city/state re-sale licensing agreements. Vendor is responsible for paying sales tax.

11. **PAYMENT.** Vendors must include a \$100.00 non-refundable deposit with Application.

12. **CANCELLATION POLICY.** No refunds will be made for rain, acts of God or any other reason.
